On 12/7/23 at approximately 2030 hrs the victim, Nancy Petit telephoned the Sarasota Police Department to report a grand theft. Petit reported she had ordered approximately \$1830.00 worth of merchandise and was tracking the package on UPS. Petit reported she received an alert indicating the package had arrived at the front door at approximately 1730 hrs. Petit reported she was not home and realized her packages were not at her front door after arriving home.					
Petit began to reivew surveillance video from her Nest camera and observed a white vehicle approaching the front door at 1829 hrs. The driver was described as a Hispanic female wearing a black long-sleeve shirt, blue pants, and white shoes. In the video, the female approaches the five boxes stacked at the front door to Cosmopolitan Ct. The female removes all five boxes from the front door and places them in the front passenger seat of the vehicle. The female drives away with the boxes. When the vehicle leaves, a portion of the license plate can be seen. The first two characters of the license plate appear to be "17". The vehicle in the video is a white Infiniti 4-door. Petit reported she gave no one permission to remove the packages.					
SPD Investigator Motafches assisted your affiant in this investigation by searching for any Infinitivehicles on surrounding license plate recognition systems. Investigator Motofches located a photo of a white 2004 Infiniti Q45 FL tag 17DNFE matching the description of the vehicle observed in the video during the grand theft. A search of the registered owner for this vehicle revealed it was owned by Angelique Erica Poquette DOB/08/23/1979. A driver's license photo of Poquette positively identified her as the same female in the video stealing the five boxes of merchandise.					
The following five items were stolen along with their approximate values 4 pairs of Converse sneakers (2 white, 1 gray/blue, 1 black/white) valued at \$230 00 12 Lumen exterior LED lights (3 dark gray and 12 light gray) valued at \$1,600 00 Total loss is approximately \$1,830 00 and Petit wished to seek prosecution
