On 12/08/23 at 2318hrs I conducted a traffic stop on a white Infiniti, bearing FL tag- 17DNFE at the intersection of Winton Ave/ 32<sup>nd</sup> ST. Note: Sarasota Police had an in-hand felony warrant for the registered owner, Angelique E. Poquette. (Reference case number 23-059506)

Contact was made with Poquette at the driver side window of the vehicle and she was ordered to step out. Poquette was placed into custody without incident.

Due to Poquette using her vehicle while committing the theft, Sarasota Police department seized the vehicle and transported it to Sarasota Police headquarters. Officers observed a white rock substance in plain view sitting inside the cup holder that was on Poquette's side of the center console which was also in the immediate reach of Poquette. The white rock substance located was field tested and a positive result for cocaine was received, weighing 0.2 grams.

Poquette was searched prior to being transported and a glass pipe was located in the left pocket of her jacket which is also consistent with narcotic use.

Pictures of the narcotics were uploaded via AXON capture.

Angelique E. Poquette was arrested for violating F.S.S 893.13(6)(a), possession of controlled substance and F.S.S 893.147(1), possession of drug paraphernalia. Poquette was also charged for knowingly driving while license suspended or revoked F.S.S 322.34 (2)(B), due to her license being revoked on 10/24/2023.

This incident was captured on my body worn camera and occurred in the city limits of Sarasota, FL.
