# Bias-Free Policing



This brochure is designed to educate the public on the issue of bias-based policing including what it is and what you can do if you believe you have been a victim.

#### To our Residents, Business Owners, Commuters, and Visitors.

We are here to protect the community. Law enforcement officers are required to use skills developed through observation, training, and experience in order to identify suspicious circumstances, unusual occurrences, and violations of law (municipal ordinance, criminal and traffic) and to act according to the situation. We contact people who, according to our training, experience, and knowledge, are in a place or are acting in a way to make us believe that a crime was committed, is about to be committed or is in the process of being committed. This proactive approach aids in the detection and apprehension of criminals, maintains the safety of our streets and highways, and protects our citizens and community from crime.

We want to do the right thing.

Discriminatory enforcement practices can alienate our citizens, foster distrust of police in the community, invite media scrutiny, legislative action, and judicial intervention, and potentially lead to allegations of constitutional and civil rights violations.

As we perform our duties, it is imperative that we afford all citizens the Constitutional and fundamental right to equal protection under the law.

# What is Biased Policing?

The inappropriate consideration of specified characteristics when enforcing the law or providing police services. Special characteristics may include race, ethnic background, gender, gender identity, sexual orientation, religion, socioeconomic status, age, disability, political status, or any other identifiable group.
